## **Doing the Right Thing**

**TUESDAY, JAN. 30, SEEMED LIKE** a routine workday for Somerset Rural Electric Cooperative (REC) Meter Technician Jeff Brant. He had spent the morning installing a relay switch and was headed to a commercial meter reading job near Mount Davis.

While driving along Brushcreek Road in Northampton Township, Jeff noticed a woman lying on the ground waving for help. When he approached the woman, 85-year-old cooperative member Shirley Werner, it became apparent she had fallen while getting her mail. As Jeff spoke with Shirley, he realized she was unable to get up and had been lying on the cold, wet ground for quite some time. She told Jeff

six cars had gone by and no one stopped. Since she was unable to walk to her house, he helped her into his truck to warm up.

Shirley told Jeff her son would be there soon to take care of her. However, even after sitting up for a short time, she felt dizzy and short of breath. Jeff called 911.

Jeff knew a Somerset REC line crew was working in the area. He called crew members Roy Bittner and Adam Barnes to provide additional help. Jeff tried to flag down some passing motorists, but again, no one would stop.

The three cooperative employees helped to keep Shirley calm and comfortable by wrapping her in blankets and talking to her until the ambulance arrived. The ambulance crew took over and transported her to the hospital. Unfortunately, Shirley passed away later that day.

Somerset REC employees go through extensive training on a variety of topics. They participate in monthly training sessions and courses on-site to remind them of the safety aspects of their job. Employees are also encouraged to attend various Job Training & Safety schools organized by the Pennsylvania Rural Electric Association, the statewide trade association for the 13 rural electric cooperatives in Pennsylvania and one in New Jersey.

These safety courses include comprehensive first aid, CPR, and AED training, and all employees are required to be certified in these areas. The training teaches staff how to recognize and respond to emergency situations, in and out of the workplace, and how to provide aid until emergency personnel arrive. In this situation, Jeff, Roy and Adam did exactly that.

This case shows the importance of remaining calm, assessing the situation and determining the actions that need to be taken. Most important, it demonstrates the need to be a Good Samaritan to those in distress. By Shirley and Jeff's count, at least eight motorists passed the scene without stopping.

Debbie Werner, Shirley's daughter-in-law, expressed the family's gratitude to Jeff, Roy and Adam. Debbie teared up as she thought about how long Shirley would have suffered if the men hadn't stopped to help.

We at Somerset REC are members of our community and know the importance of doing the right thing. General Manager Rus Ogburn said it best: "The awareness of Jeff to recognize someone in distress and the willingness of all three to help a person in need perfectly reflect the way this cooperative serves our members." •



## ANDREW PHILLIPPI PROMOTED TO MANAGER OF OPERATIONS

Andrew Phillippi's promotion to manager of operations for Somerset Rural Electric Cooperative (REC) officially took effect in February. He replaces Doug Glessner, who retired after 39 years of service. Andrew began his transition to this role in June 2023, soon after Doug announced his retirement.

Andrew is a familiar face at the cooperative. He has been involved with the operations department for the past 17 years – nine years as a lineworker and eight as a staking engineer. He started his tenure with Somerset REC in 2007, when he was hired as a summer intern. That summer, he worked on the brush crew while attending Pennsylvania College of Technology. Andrew was hired as a full-time employee later that year, where he advanced to journeyman lineman.

As a lineworker, Andrew became familiar with the cooperative's service territory, canvassing the entire area, which includes parts of Somerset, Fayette, and Bedford counties and extends into Garrett County, Md. He also learned how to build and maintain the cooperative's electrical power lines.

In 2016, Andrew became a staking engineer. In this role, he managed the geographic information system to map the cooperative's service territory. Andrew also assisted with the layout and design of new line construction and the upgrading of existing facilities. In 2020, he took on oversight of the right-of-way maintenance program.

Andrew is a graduate of Rockwood Area High School and has an associate degree in electrical technology and management. He lives in Somerset Township with his wife, Amber (Kister), their daughters – Andi, 7, and Alix, 5 – and 1-year-old son Aiden. Andrew attends St. Paul's United Church of Christ in Somerset. In his spare time, he enjoys hunting, fishing, and any activities involving his family and friends.

Filling the position after Doug's retirement is a big responsibility, but Andrew hopes to build on the foundation that Doug established.
